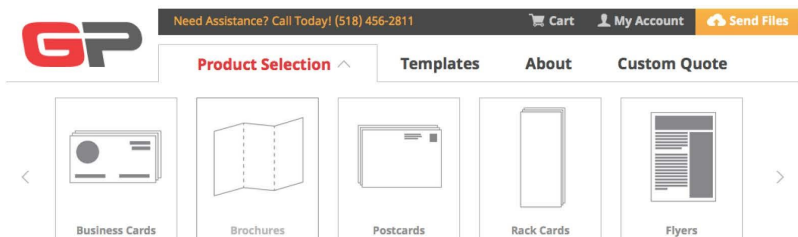

Kyle Goldy ~ A Lesson on Resilience and Survival (submitted by Chief Peter Brodie)

Prior to July 20, 2024, Kyle Goldy was a man in his 30's married to a strong, passionate and loving wife; father of two adoring daughters and living in a beautiful new home in the Town of Duanesburg. At a housewarming celebration with friends, Kyle's life suddenly changed in ways he never imagined would come his way. He suffered a significant head injury when he fell down the stairs at his home.

"Duanesburg Ambulance helped him during his time of need."

On that evening, Duanesburg Ambulance EMT Jessica Gathen, EVO Timothy Herzog and EMT Kyle Avery responded along with Duanesburg Fire to care for a man who had fallen. 30 minutes later, Kyle had been loaded to a helicopter from Air Methods (LifeNet) and was transported to Albany Medical Center Hospital the Level I Adult Trauma Center for further treatment. After a stay at Albany Med, the crew of Kimberly Sargalis EMT, Peter Brodie AEMT and Andrew Millard EVO were summoned to the house again for further evaluation of Kyle who had been acting differently according to his family. A stubborn young man, Kyle resisted treatment and transport to the hospital. Early the next morning, Kyle was transported to the hospital for further treatment by the crew of Michael Badger EMT and Evan Trombley EVO.

Kyle has had multiple surgeries and steps in his recovery that he credits

his wife, his mother and his family for their full support. While his life is quite different than before the unfortunate fall, Kyle has such a positive attitude and a commitment to living the life he wants to live. On a beautiful Saturday morning in March 2025, Kyle stopped by

Duanesburg Ambulance and spent 2 hours visiting with some of the responders and sharing his experiences after our three encounters after the fall.

While his recovery is ongoing, Kyle has returned to hunting and fishing, working at a new job with less

appointments is easier now with his new job.

During his visit, Kyle credited the outstanding work by the three crews, Duanesburg Ambulance, Duanesburg Fire and LifeNet for saving his life and providing him with great care. While he was glad

that he didn't remember the helicopter flight (he is afraid of them), he believes they provided him with great care. At a recent town board meeting, Kyle's mother spoke about how Duanesburg Ambulance saved her son's life and she credits our willingness to explain the health care system for his family and do our best to help them through a challenging time.

Working toward a Duanesburg Ambulance Tax District: What It Means for You

Our community is committed to maintaining and improving essential emergency services, including ambulance response

“...this will not increase
your taxes”

and medical aid. As part of this commitment, a new Ambulance Tax District is in the pro-

cess of being established. Duanesburg Ambulance wants to clarify what this means and reassure residents that this will not increase your taxes—it is simply a change in how funding is displayed and allocated.

What Is the Ambulance Tax District?

Previously, funding for ambulance services was included within the general town budg-

et, making it less transparent to taxpayers. The new tax district moves this funding into a dedicated line item on your tax bill, ensuring clearer accounting and easier tracking of how these critical services are funded.

Why Make This Change?

This adjustment provides several key benefits:

- **Transparency:** You will now see exactly how much is allocated to ambulance services, increasing accountability in local government spending.
- **Budget Stability:** By establishing a dedicated fund, we can ensure that emergency medical services receive the resources they need without competing with other budget priorities.
- **No Tax Increase:** This is **not a new tax**, but rather a reallocation of existing funds to a designated category.

What You Will See on Your Tax Bill

Going forward, your tax bill will include a separate line item labeled “Ambulance Tax District.” The amount listed represents the portion of your taxes already designated for ambulance services—it is not an additional charge.

Continued Commitment to Emergency Services

Duanesburg Ambulance’s goal is to ensure that ambulance response times remain fast, services remain high quality, and funding remains stable. This change allows us to do just that, while keeping you informed about where your tax dollars go.

We appreciate your support and understanding as we continue to work with the Town Board to make this improve-

ment to our community’s financial transparency. If you have any questions or concerns, please reach out to me or a town board member for more information.

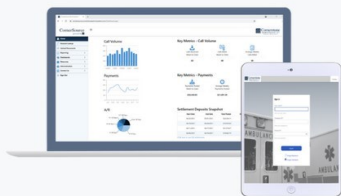



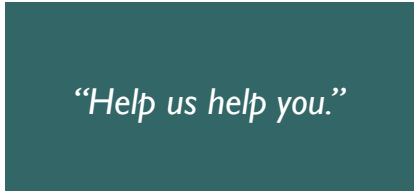

The Duanesburg Ambulance Corps has an excellent working relationship with all the finance departments from Ellis Hospital, Albany Medical Center, St. Mary's, Bassett Hospital in Cobleskill, St. Peters, Saratoga. It is our objective for all patient's that are transported to any of the local hospitals, to obtain the patient's medical insurance information within three days from the day of transport. This insurance information is provided to our billing company (Cornerstone) to preclude you from receiving an invoice for service rendered.

In those instances where Duanesburg Ambulances responds to a **911 call**, and the medical staff conducts a medical assessment, and the patient refuses transport to a hospital, or upon completion of the medical assessment, a determination was made that the patient did not meet the criteria for transport, there is a minimal charge for providing the service. The cost is **\$156.18** and can be billed to patient's insurance company.

In those instances, whereby the patient either refuses transport or does not meet

the criteria for transport, one of our crew members will request the patient's insurance. If a situation existed where this was not feasible, a crew member will leave a card with you that looks like this.

The cost associated is **\$156.18**, and can be billed to patient's insurance company.

In the event the patient's insurance was enabled not obtained, the letter (1) following on page 19, will be sent via USPS to the patient's address on file.

It is highly encouraged that this letter be responded to.

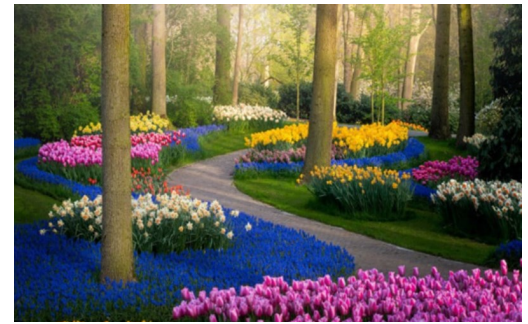

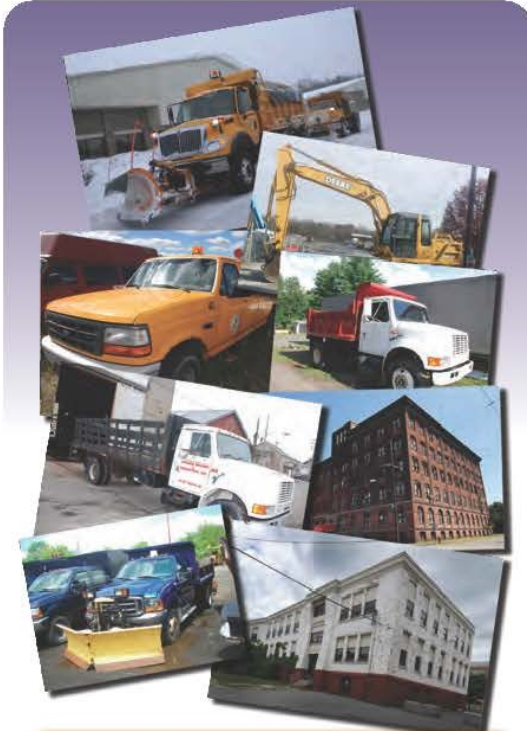

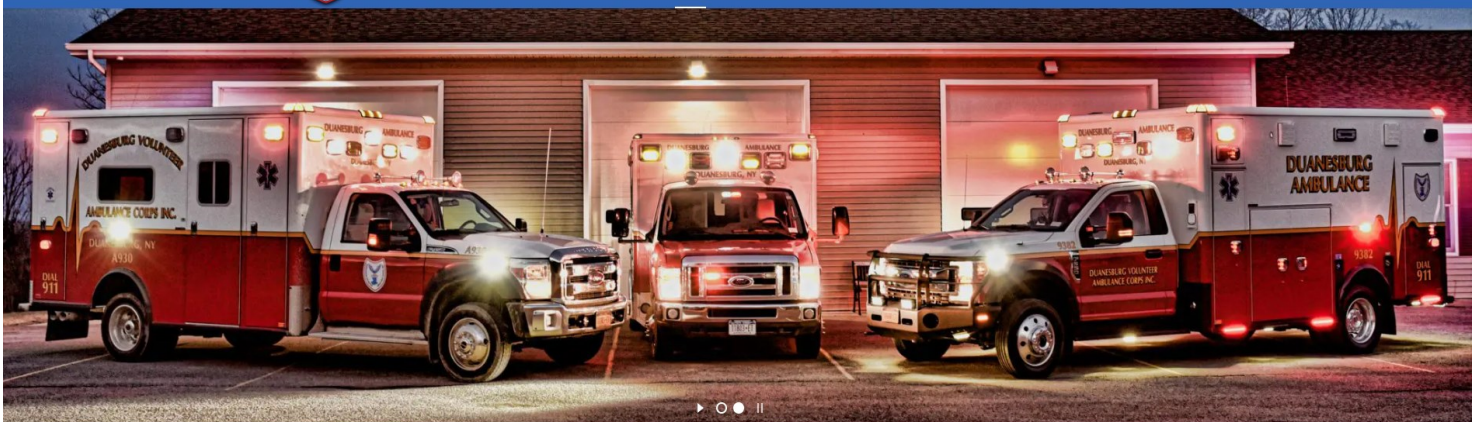

DA also provides mutual aid to surrounding communities. The Corps is enrolled in the Schenectady County Mutual Aid and MCI plans as well as the regional plan for the six counties in the Hudson-Mohawk Regional EMS Council. Our crews also provide stand-by support for various sporting events and larger public gatherings in town; additionally, the volunteers have staffed fire scenes with the six fire departments covering the Town of Duanesburg.
